MEMBERSHIP REQUIREMENTS**

*Corporate Membership: Owners & operators of public & private port terminals located on the Gulf of Mexico or in navigable waters in Texas, Louisiana, Alabama, Florida or Mississippi or on the Eastern coast of Mexico which are for hire to the general public or which terminals are used in serving oceangoing vessels carrying general cargo or which are for hire to embark and disembark passengers to or from cruise vessels.*

*Associate Membership: Limited to members & officials or former members & officials of legally established port authorities; governmental officials & governmental engineers; faculty members of institutions of learning; executive officers of private port terminal companies; boards of trade; chambers of commerce; civic associations & institutions whose organized purpose is for the encouragement of world trade & commerce.*

**NOTE: PORT TERMINALS OPERATED BY TRANSPORTATION COMPANIES PRINCIPALLY FOR THE HANDLING OF CARGO MOVING IN LINE HAUL OVER THEIR OWN LINES IN AND OUT OF A PORT SHALL NOT BE ELIGIBLE FOR MEMBERSHIP. ELIGIBILITY FOR AND ELECTION TO MEMBERSHIP SHALL BE DETERMINED BY A MAJORITY VOTE OF THE MEMBERS ATTENDING THE SPRING OR FALL MEETING.**
